Terms and Conditions

Website Use

These terms define the boundary between access and permission, between information and reliance, and between the intellectual work of the Press and the platforms through which it is encountered.

These Terms and Conditions govern access to and use of invisiblearchitecturepress.com. By using the website, you agree to these terms.

1. About the Website

The website is operated by Invisible Architecture Press, an independent publishing imprint based in Copenhagen, Denmark. It presents books, research, publishing principles, ethical standards, and contact information relating to the Press.

The website may be changed, suspended, expanded, or withdrawn at any time. Publication dates, formats, prices, availability, ISBN details, external links, and descriptions may change as projects develop.

2. Eligibility and Acceptance

You may use the website only if you have legal capacity to do so under the laws applicable to you. If you use the website on behalf of an organisation, you confirm that you are authorised to bind that organisation to these terms.

If you do not agree with these terms, do not use the website.

3. Books, Research, and Publication Status

A title described as forthcoming, in development, provisional, or planned has not necessarily been released. Cover designs, subtitles, page counts, publication dates, prices, formats, and distribution channels may change before publication.

Research papers, abstracts, summaries, and publication descriptions are provided for intellectual and informational purposes. A reference to future work does not constitute a guarantee that the work will be completed, released, or distributed through any particular platform.

4. Purchases Through Third Parties

The Press does not currently sell books directly through this website. Buttons or links may direct visitors to Amazon or another independent retailer or distributor.

Any purchase, payment, delivery, return, refund, account, tax, or customer service issue arising on a third-party platform is governed by that platform's own terms and policies. The Press is not the payment processor, merchant of record, or delivery provider for such transactions unless expressly stated otherwise.

5. Intellectual Property
